NOTICE OF COPYRIGHT

COPYRIGHT PERMISSION

Instructors are responsible for evaluating, on a case-by-case basis, whether the use of a copyrighted work requires permission or qualifies as fair use. When permissions are needed, instructors or their departments are expected to make any required arrangements. University Libraries will provide consultation and assistance to instructors in qualifying any specific use as fair use.

Please note: For eReserve access to materials from the *Harvard Business Review*, **copyright clearance is REQUIRED.**

COURSE RESTRICTION

Electronic reserve courses require course-level password authentication.

Distribution of the password is limited to students enrolled in the course. Password protection creates a secure environment for access to copyrighted works that allows University Libraries to make materials available to students under the provisions of fair use. Limiting access to students who are registered in your class helps assure that materials are used only for educational purposes and minimizes any impact on the market for the original work. When filling out the submission form, please provide **complete citations** of the material to be placed on reserve and the **date by which they will be needed**. In the event of a processing backlog, **the date of the assignment** will help ensure that materials are ready for students when needed. Early in the semester, the due date for readings may take priority over the submission date.

If an electronic resource of an article is available via a licensed on-line resource such as JSTOR or Academic Search Premier and the license permits course reserve use, we will generate a link to the article. **In these cases, photocopies will not be needed, just complete bibliographic citations.**
